**South Sutter Water District, Project No. 2997-006 - California
Order Approving Revised Exhibit G Drawings**

(Issued June 19, 1990)

On May 25, 1990, South Sutter Water District filed as-built revised exhibit G drawings for the Camp Far West Project, FERC Project No. 2997, in compliance with the Commission's Order Amending License, issued April 19, 1990 [[51 FERC ¶62,051](#)].

On March 13, 1987, the licensee filed revised exhibit F and G drawings showing the Camp Far West Project as-built. The revised exhibit G drawings excluded the authorized 1.92-mile-long, 60-kV transmission line. The licensee proposed to use Pacific Gas and Electric's (PG&E) 60-kV transmission line instead of constructing a new line.

By letter dated April 28, 1987, the Acting Director, Office of Hydropower Licensing, determined that the line was a primary transmission line and thus would have to be part of the license, to be owned and operated by the licensee. The Acting Director offered three suggestions which the licensee might follow. Namely, (1) the District could acquire sufficient rights to the transmission line so that PG&E need not be a licensee (2) PG&E could

become a joint licensee with the District, or (3) PG&E could apply for a separate transmission line license. By orders issued April 19, 1990, the transmission line was eliminated from the license for the Camp Far West Project, FERC Project No. 2997, and a new license was issued to Pacific Gas and Electric for the Camp Far West Transmission Line Project, FERC Project No. 10821. The order amending license revised the project boundary and required the submittal of revised exhibit G drawings showing the removal of the transmission line from the Camp Far West Project. The licensee filed the required exhibits on May 25, 1990.

The Director orders:

(A) The following exhibits conform to the Commission's Rules and Regulations and are approved and made a part of the license superseding the existing exhibits.

(B) The superseded exhibit G drawings are eliminated from the license.

(C) Within 90 days of the date of issuance of this order, the licensee shall file an original of the approved exhibit G drawings reproduced on silver or gelatin 35-mm microfilm mounted on Type D (3 1/4" x 7 3/8") aperture cards for each drawing. In addition, the licensee shall file two Diazo-type duplicate sets of aperture cards. The original set and one duplicate set of aperture cards should be filed with the Secretary of the Commission. The remaining duplicate set of aperture cards should be filed with the Commission's San Francisco Regional Office. The FERC drawing numbers (2997-10 through 2997-12) shall be shown in the margin below the title block of the microfilmed drawings and also in the upper right corner of each aperture card. The top line(s) of the aperture cards shall show the FERC exhibit (i.e., F-1, G-1, L-1), Project Number, Drawing Title, and date of this order.

(D) This order is issued under authority delegated to the Director pursuant to section 375.314 of the Commission's regulations. Section 385.1902 of the Commission's regulations provides 30 days from the date of this order for an appeal to the Commission of this action. Filing an appeal does not stay the effective date of this order or any date specified herein.
