**South Sutter Water District, Project No. 2997-013 - California
Order Amending License**

(Issued April 19, 1990)

On June 26, 1989, South Sutter Water District (SSWD) filed an application to amend its license for the Camp Far West Project No. 2997, located on the Bear River in the Counties of Placer and Yuba, California. SSWD requests Commission approval to delete from its license the project's transmission line (line). The 1.92-mile-long, 60-kV line approved in the current license was constructed by the Pacific Gas and Electric Company (PG&E). SSWD, for ease of operation and maintenance, seeks to remove the line from its license in order for PG&E to seek a license, in a separate action, to own, operate, and maintain the line. ¹

Notice of the application has been published. No protests or motions to intervene were filed in this proceeding, and no agency objected to issuance of this order.

The existing line is a primary line, as defined by section 3(11) of the Federal Power Act, for the Camp Far West Project No. 2997. ² The line is connected to the existing PG&E's 60-kV, Smartsville-Allison transmission line. Removal of the line from the license for Project No. 2997 and licensing it to PG&E is an administrative action. In several similar cases, the Commission has issued separate licenses for the transmission line portion and the generation portion of a project. ³

The Director orders:

(A) South Sutter Water District's application for amendment of license for Project No. 2997, filed on June 26, 1989, is approved, thereby removing the 1.92-mile-long transmission line from the license.

(B) Ordering Paragraph (B) of the license is modified by deleting paragraph (B)(2)(i) from the license.

(C) Under "Project Description" on page 1 of the license, item (6) is deleted.

(D) The licensee shall, within 90 days of issuance of this order, file for Commission approval revised exhibit G drawings showing the transmission line removed from the project boundary for Project No. 2997.

(E) This order is issued under authority delegated to the Director and is final unless appealed to the Commission by any party within 30 days from the issuance date. Filing an appeal does not stay the effective date of this order or any date specified in this order. The licensee's failure to appeal this order shall constitute acceptance of the order.
