Order Approving Revised Exhibits

On December 2, 2003, South Sutter Water District (Licensee) filed revised drawings of the three auxiliary dams for the Camp Far West Project, FERC Project No. 2997. The project is located on the Bear River, Nevada, Yuba, and Placer Counties, California.

The filing was in response to a Commission letter, dated October 3, 2003, which required the licensee to file a revised Exhibit A and revised Exhibit F and G drawings showing the three auxiliary dams around the rim of the Camp Far West Reservoir.

The Exhibit A Project Description narrates the south and north wing dams and the dike. The two revised Exhibit F drawings show the plans and cross-sections of the south and north wing dams and the dike. The revised Exhibit G shows the locations of the south and north wing dams and the dike. The drawings adequately show the authorized project features and conform to the Commission's rules and regulations. This order approves the drawings and Exhibit A. Ordering Paragraph (C) requires the filing of aperture cards of the approved drawings.

The Director orders:

(A) The following exhibits are approved and made part of the license:

(B) The superseded exhibit drawings are eliminated from the license.

(C) Exhibit A, filed on December 2, 2003, describing the auxiliary dams and the dike is approved and made part of the license.

(D) Within 90 days of the date of issuance of this order, the licensee shall file three sets of aperture cards of the approved drawings. The aperture cards should be reproduced on silver or gelatin 35-mm microfilm. All microfilm should be mounted on Type D (3 1/4" x 7 3/8") aperture cards.

Prior to microfilming, the FERC Drawing Number (2997-14,-15, and-16) shall be shown in the margin below the Title Block of the approved drawing. After mounting, the FERC Drawing Number should be typed in the upper right corner of each aperture card. Additionally, the Project Number, FERC Exhibit (F-1, F-3 and G-1), Drawing Title, and date of this order should be typed in the upper left corner of each aperture card. See Figure 1.

Two original sets of aperture cards should be filed with the Secretary of the Commission. The remaining set should be filed with the Commission's San Francisco Regional Office.

(E) This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to [18 C.F.R. §385.713](#).
